 - a. ONCA 15-60, An Act to authorize and appropriate one million four hundred thousand dollars (\$1,400,000) to the Health Benefit Plan Fund from FY 2016 General Funds to pay the Medigap Coverage Premiums of qualified Osage members; and to establish an alternate effective date. (Edwards)
 - b. ONCA 15-74, An Act to amend the Osage Nation Office of the Attorney General Act at 15 ONC § 3-107; to charge the Attorney General with implementing amendments to the Osage Nation Constitution, and then to publish the updated document; and to establish an alternate effective date. (Whitehorn)
 - c. ONCA 15-75, An Act to protect human remains, funerary objects, graves, and cemeteries; and to establish an alternate effective date. (Maker)
 - d. ONCA 15-76, An Act to govern the conduct of Osage Nation Elections, including elections for Principal Chief, Assistant Principal Chief, Osage Nation Congress, elections for the retention of Judges of the Judiciary, and other elections required by the Constitution and by law; and to establish an alternate effective date. (Norris)
 - e. ONCA 15-77, An Act to repeal and replace the Budget Parameter and Limitation Act, enacted last under ONCA 13-67; and to establish an alternate effective date. (Jech)

- f. ONCA 15-78, An Act to provide an appropriation to the Office of the Attorney General of the Osage Nation for fiscal year 2016 in the amount of nine hundred forty thousand six hundred sixteen dollars (\$940,616); and to establish an alternate effective date. (Jech)
- g. ONCA 15-79, An Act to provide an appropriation to the Office of the Principal Chief of the Osage Nation for fiscal year 2016 in the amount of one million seven hundred fourteen thousand ninety three dollars (\$1,714,093); and to establish an alternate effective date. (Jech)
- h. ONCA 15-80, An Act to provide for an appropriation to the Legislative Branch of the Osage Nation for fiscal year 2016 in the amount of two million four hundred seven thousand one hundred seventeen dollars (\$2,407,117); and to establish an alternate effective date. (Jech)
- i. ONCA 15-81, An Act to provide an appropriation to the Judicial Branch of the Osage Nation for fiscal year 2016 in the amount of three hundred ninety four thousand seventy one dollars (\$394,071); and to establish an alternate effective date. (Jech)
- j. ONCA 15-82, An Act to provide an appropriation to the Land, Commerce and Public Safety Division of the Osage Nation for fiscal year 2016 in the amount of eleven million three hundred twenty three thousand fifty two dollars (\$11,323,052); and to establish an alternate effective date. (Jech)
- k. ONCA 15-83, An Act to provide an appropriation to the Health, Fitness and Wellness Division of the Osage Nation for fiscal year 2016 in the amount of fourteen million five hundred thirteen thousand eight hundred twelve dollars (\$14,513,812); and to establish an alternate effective date. (Jech)
- l. ONCA 15-84, An Act to provide an appropriation to the Government Operations Division of the Osage Nation for fiscal year 2016 in the amount of nineteen million eight hundred ninety thousand four hundred twenty two dollars (\$19,890,422); and to establish an alternate effective date. (Jech)
- m. ONCA 15-85, An Act to provide an appropriation to the Education and Early Childhood Services Division of the Osage Nation for fiscal year 2016 in the amount of nine million seven hundred eight thousand four hundred seventy two dollars (\$9,708,472); and to establish an alternate effective date. (Jech)
- n. ONCA 15-86, An Act to provide an appropriation to the Cultural Preservation, Arts, Heritage and Language Division of the Osage Nation for fiscal year 2016 in the amount of three million one hundred fifteen thousand one hundred six dollars (\$3,115,106); and to establish an alternate effective date. (Jech)

- o. ONCA 15-87, An Act to provide an appropriation to the Child, Family and Senior Community Services Division of the Osage Nation for fiscal year 2016 in the amount of four million five hundred five thousand seven hundred eight dollars (\$4,505,708); and to establish an alternate effective date. (Jech)
- p. ONCA 15-88, An Act to provide an appropriation to the Boards, Commissions, Authorities and Utilities of the Osage Nation for fiscal year 2016 in the amount of one million nineteen thousand three hundred fifty one dollars (\$1,019,351); to consent to spending of an Independent Agency; and to establish an alternate effective date. (Jech)
- q. ONCA 15-89, An Act to establish the summer program to introduce Osages to careers in the health industry at an early age; and to establish an alternate effective date. (Shaw)
- r. ONCA 15-90, An Act to amend ONCA 12-107 to require unexpended monies appropriated for specific capital projects to revert back to the Treasury and to add reporting requirements; and to establish an alternate effective date. (Shaw)
- s. ONCA 15-91, An Act to amend and restate the Osage Nation Gaming Reform Act of 2007, 14 ONC § 12-105; and to establish an alternate effective date. (Whitehorn)
- t. ONCR 15-19, A Resolution to approve the Osage Nation Election Board rules and regulations governing elections in accordance with the Osage Nation Election Code. (Norris)
- u. ONCR 15-20, A Resolution to authorize and approve execution of a "Contract for Treatment Services or Other Integrated Services-Fixed Rate FY16" with the State of Oklahoma-Department of Mental Health and Substance Abuse Services; and to authorize a limited waiver of sovereign immunity from suit and a consent to jurisdiction.
