ONCA 19-34, An Act to amend ONCA 18-48 authorize and appropriate the amount of two hundred sixty two thousand six hundred nineteen dollars (\$262,619) in federal funds to Community Health Representative and to reduce the tribal appropriation in the amount of two hundred sixty two thousand eight hundred nine dollars (\$262,809); and to establish an alternate effective date. (Pratt)
  - f. ONCA 19-35, An Act to authorize and appropriate the amount of one hundred fourteen thousand six hundred thirty nine dollars (\$114,639) in federal funds to the Education Department Johnson O'Malley Program; reduce the tribal appropriation by the amount of sixty nine thousand one hundred fifty eight dollars (\$69,158); and to establish an alternate effective date.
