 - a. ONCA 18-57, An Act to establish in Osage law a budgetary process that is governed by the principles of Transparency and Accountability, defining terms, and establishing limitations; and to establish an alternate effective date. (Potts)
 - b. ONCA 18-58, An Act to provide an appropriation to the limited liability company, Bluestem Ranch, LLC in the amount of one million one hundred thousand dollars (\$1,100,000) out of the Economic Development Fund; and to establish an alternate effective date. (Whitehorn)
 - c. ONCA 18-59, An Act to amend § 2-311 of Title 15 to require the Treasurer to report the total amount of unassigned revenues and unobligated funds to the Osage Nation Congress; to require the total to be distributed to the Economic Development Fund, the Retained Revenue Fund and the Permanent Fund; and to establish an alternate effective date.  - d. ONCA 18-60, An Act to authorize and appropriate one hundred eighty thousand dollars (\$180,000) to the Osage Nation Foundation to be administered and distributed as donations and matching grants for arts, culture and history; and to establish an alternate effective date. (Edwards)
 - e. ONCA 18-61, An Act to amend and restate 15 ONC § 5-101 *et seq.* and to establish an alternate effective date. (Edwards)
 - f. ONCR 18-27, A Resolution to authorize the Principal Chief of the Osage Nation to execute real property leases and right-of-way easements on restricted Indian lands on behalf of the Osage Nation through October 1, 2019. (Whitehorn)

- a. ONCA 18-33, An Act to authorize and appropriate eight million one hundred fifty thousand dollars (\$8,150,000) to the Higher Education Scholarship Fund; and to establish an alternate effective date. (Edwards)
- b. ONCA 18-43, An Act to provide an appropriation to the Office of the Attorney General of the Osage Nation for fiscal year 2019 in the amount of one million seven hundred seventy three thousand seven hundred seventy seven dollars (\$1,773,777); and to establish an alternate effective date. (Whitehorn)
- c. ONCA 18-50, An Act to amend ONCA 17-101 to provide a supplemental appropriation to the Office of the Attorney General for fiscal year 2018 in the amount of fifty thousand dollars (\$50,000); and to establish an alternate effective date. (Edwards)
