Restricted Land Services Limitation

All services available to individual restricted landowners and life estate holders of restricted property are subject to limitation due to availability of annual appropriations.

Disclaimer: Application does <u>not</u> guarantee selection in the Restricted Land Program. The Osage Nation retains the authority to grant or refuse approval for any services associated with this program. If you are requesting noxious weed spray, the chemical must be applied by Bluestem Aerial, as the Osage Nation covers both the cost of the chemical and its application. Bluestem Aerial requires a minimum of 40 acres, as smaller areas make aerial application challenging. Applications for the Fencing, Boundary Surveys, Noxious Weed Program, and the Pond Program will be accepted between October 15, 2025 and December 15, 2025. No application will be considered after the application process has closed for the year. There is no deadline for the Critical Road Access and Prescribed Burn/Cedar Tree Removal Program.

Applications submitted by undivided restricted landowners must adhere to 25 CFR § 162.012. If percentage requirements are not met, application is deemed incomplete.
