DRAWING & FORM DEADLINE

Date: Thursday, April 14, 2022

Location: Campus Park Main Arbor

Candidates requesting a campsite must:

- Be listed on the General Election ballot.
- Submit the Campsite Request Form by **1:00 p.m. on Thursday, April 14, 2022** to ᄀᄃᄃᄃᄃ Elections.
 - Scan and e-mail to electionoffice@osagenation-nsn.gov.
 - Fax to (918) 287-5292.
 - Deliver to 608 Kihekah, Pawhuska, Ok.

Campsites will be:

- Chosen by drawing.
- Free of charge to candidates.
- Predetermined and mapped as to size and location.
- Chosen from the Campus Park.
 - Any remaining candidates may choose to be listed on the cancellation list.
 - * Cancellations must be submitted in writing before **4:30 p.m. on Wednesday, June 1, 2022** by the Candidate to ᄀᄃᄃᄃᄃ Elections.
 - * If there are multiple Candidates listed, then a drawing will be held using the same process as the original drawing to determine campsites.

The Election Supervisor will conduct the drawing using the following process:

- Candidate names will be preprinted for the drawing and placed in the hopper in the presence of the Candidates.
- Candidate names will be drawn one at a time.
- Candidates or their representative will be asked to determine the location of their campsite.
- Candidate names will be placed on the map at the time of the drawing.
- If the Candidate or their representative is not present at the start of the drawing, then their name will not be placed in the hopper.
- If a Candidate submits their form by the deadline but misses the drawing, then campsites will be determined on a first come first serve basis. Contact the Election Office immediately to reserve your campsite.

RULES

All candidates and constituents are bound by the Osage Nation Election Code and Osage Nation Election Board Rules and Regulations. The following rules have been established by ᏍᏏᏏᏏ Elections.

1. Security – The Osage Nation Police Department has been designated as security and enforcement for Osage Nation Elections.
2. Liability – All candidates are responsible for property located within their campsites.
 - a. The Osage Nation is not responsible for any property destroyed or removed from campsites.
 - b. Do not leave any material, equipment, or personal belongings that you do not want to be stolen at your campsite.
3. Set Up – Candidates will be allowed in the Campus Park to set up beginning at 12:00 p.m. on Friday, June 3, 2022. Campsites will be marked with the Candidate names.
 - a. If there is any discrepancy or challenge as to the location of a campsite, the Osage Nation Election Supervisor will be the resolution authority.
 - b. If there is no resolution, the Candidate must forfeit their campsite.
4. Tear Down – All campsites must be completely removed by 4:00 p.m. on Tuesday, June 7, 2022.
5. Tents – Tents are permitted and must be no larger than the Candidate's allotted campsite.
 - a. All tent stakes must be marked and highly visible to foot traffic using brightly colored tape or some other distinguishable means.
6. Labor and Materials – All Candidates are required to provide all labor and materials necessary for setting up and tearing down their campsite.
7. Vehicles – Vehicles will be allowed in the campsite area during set up and tear down hours only.
 - a. All vehicles must be moved to the parking area by 10:00 a.m. on Election Day.
 - b. All violators will be towed at their own expense.
8. Signs – Campaign signage is prohibited on Osage Nation premises, with the exception of Election Day. Campaign materials are ONLY allowed in the areas of the campsites and within the boundaries of each Candidate's campsite.
9. Electric – There is not enough electric for all camps to have electric.
 - a. The three covered arbors do not hold enough electric amps to run fans, generators, refrigerators, etc.
 - b. No gasoline generators will be allowed for safety reasons.
 - c. No extension cords will be allowed between campsites.

- d. General ambient lighting will be provided for safety throughout the campsite area.
10. Waste – Trash and recycling containers will be provided. Candidates are responsible for all trash in and around their campsite during Election Day and must have it contained in bags.
 11. Cooking Grates and Fires – There are several cooking grates throughout the Campus Park and will be included in the nearest campsites.
 - a. All other fires must be marked and contained in some manner by outdoor grill or by cook grate shields for safety to others.
 - b. **IMPORTANT:** If there is a high fire alert, safety recommendations will be followed.
 12. Restrooms – Temporary facilities will be provided and placed in easily accessible areas, if possible.
 13. Drugs and Alcohol – Drugs and alcohol are prohibited on the Osage Nation Campus.
