ELIGIBILITY AND QUALIFICATIONS

Osage Nation Constitution, Article VII, Section 3, Qualifications

Enrolled members of the Osage Nation, who are at least thirty-five (35) years of age on that date of the election, who have never been convicted of a felony, are eligible to become a candidate for the office of Principal Chief of the Osage Nation.

Osage Nation Constitution, Article VII, Section 4, Disqualifications

The Principal Chief shall not hold any other office or position of profit under the Osage Nation nor hold any office, be it elected or appointed, under any other tribal government or state, county or federal government. A person shall be disqualified to hold the Office of Principal Chief after serving five (5) full terms in that position, plus any initial partial term fulfilled as the result of a vacancy.

Osage Nation Code, Title 12, Chapter 5, Section 5-101, Qualifications for Principal Chief and Assistant Principal Chief

Any enrolled member, who is at least thirty-five (35) years of age on the date of the election and has never been convicted of a felony, is eligible to become a candidate for the office of Principal Chief or Assistant Principal Chief of the Osage Nation.

Osage Nation Code, Title 12, Chapter 5, Section 5-104, Disqualifications – Executive

A. Pursuant to the Constitution, Article VII, Section 4, the Principal Chief and the Assistant Principal Chief shall not hold any other office or position of profit under the Osage Nation nor hold any office, be it elected or appointed, under any other tribal government or any state, county, or federal government. For the purposes of this section, “office” is defined as an elected or appointed position of trust or authority, where the person elected or appointed carries out some portion of a government’s sovereign powers.

- I. Any candidate for Principal Chief or Assistant Principal Chief shall not be certified as a candidate for office if a felony conviction appears on a certified court record.

HOW TO FILE

- ✦ Candidates are required to appear in person to submit their Declaration of Candidacy between the hours of 8:00 am and 4:30 pm during the candidate filing period prescribed by Osage Nation law for this election.
- ✦ The Declaration of Candidacy form submitted must bear the candidate's original signature, which shall be witnessed by a  Election notary.
- ✦ **Early, late, or incomplete submissions cannot be accepted.**
- ✦ Declaration of Candidacy forms cannot be accepted by email, fax, or mail.

FILING FEE

The Declaration of Candidacy shall be accompanied by a cashier's check or money order payable to Osage Nation Elections in the amount of four hundred dollars (\$400).

CANDIDATE'S NAME

The candidate's name that appears on the ballot will be the same as their first name, last name, and suffix listed on their government-issued photo identification; however, a candidate may use their nickname in place of their first name.

CAMPAIGN BANK ACCOUNT

Prior to filing for office, candidates are required to establish a separate bank account to be used for campaign purposes only in the name of the candidate or the candidate's campaign. Proof of the bank account is required to be provided at the time of filing and must show the account name and number.

- ✦ All campaign donations shall be deposited into this account, including the candidate's personal funds used for campaign purposes.
- ✦ All expenditures used for campaign purposes shall be spent from this account.
- ✦ Failure to use this account for any and all donations and expenditures shall result in a \$125 fine.

WHERE TO FILE

The Declaration of Candidacy, accompanied by the filing fee and required documentation, must be filed in person at the  Elections Office located at 813 Grandview Ave. (West entrance) in Pawhuska, Oklahoma.
