- D. Only qualified voters may file a contest of candidacy. Any contest of candidacy shall be filed with the Office, and a public hearing shall be held to determine the validity of said candidacy. Any such contest shall be filed within three business days of the posting of the names of all certified candidates, and a hearing on such a contest shall be held within three business days of the contest's filing. The verdict of the Board shall be final. If necessary, an amended list of all certified candidates shall be posted in a public place within twenty-four (24) hours of the verdict.

SECTION 2. ALTERNATE EFFECTIVE DATE

This bill is effective upon signature of the Principal Chief or upon signature of the Speaker of the Osage Nation Congress following legislative override.
