Requests for Information must be received by February 5, 2026 to the proposal. Any and all addenda will be circulated to all proposal holders by February 6, 2026, which is three (3) days prior to submission deadline.

Purpose of Solicitation:

Osage LLC’s primary objective is to construct a pond on the Osage Nation Ranch as needed and in compliance with Natural Resources Conservation Service (NRCS).

The individual or company shall have a minimum of three (3) years of experience.

Scope of Services:

The individual and/or company must provide the following services to the Owner as needed and agreed upon between the parties:

West Murray

- i. This pond will consist of the construction of a 3500 cuyd borrow pit below the permanent waterline. That material will be used to fill in the breach and add height to the dam.
- ii. The dam will need to be brought up to NRCS standards and specifications with a 3:1 front slope and a 2:1 back slope with a 10ft top.

- iii. The principal spillway will be installed in the deepest fill and will consist of an estimated length of 75ft of 12” diameter pipe.
- iv. Pond will need to stockpile any available topsoil for replacement onto the dam after completion.

These are estimates, the yardage and pipe length may vary slightly when the pond is staked in the field.

All work must be completed in compliance with applicable state, local, federal and Osage Nation codes.

Format of Responses:

To be considered for award, a firm and/or individual must submit a complete response to this Request for Proposals and include each of the following:

1. Introduction – indicate the name of individual and/or company, brief description of the company: which should include the size, contact person and the address of the office to which this project will be assigned.
2. Statement of Experience - include work with Native American Tribes
3. Qualifications

5. Project Understanding/Approach
6. Special Requirements – Osage preference with Proof of Osage Membership and Majority Company Ownership
7. Compensation/Quote
