Requests for Information must be received by February 5, 2026 to the proposal. Any and all addenda will be circulated to all proposal holders by February 6, 2026, which is three (3) days prior to submission deadline.

### **Purpose of Solicitation:**

Osage LLC’s primary objective is to construct a pond on the Osage Nation Ranch as needed and in compliance with Natural Resources Conservation Service (NRCS).

The individual or company shall have a minimum of three (3) years of experience.

### **Scope of Services:**

The individual and/or company must provide the following services to the Owner as needed and agreed upon between the parties:

#### Horsetrap

- i. This pond will consist of the construction of a 3000 cuyd excavated pond below the existing old pond site
- ii. A principal spillway pipe will be installed in the new pond
- iii. The principal spillway pipe will be 70ft of 12" steel pipe

iv. The old pond dam will need to be breached after the new pond is complete

*These are estimates, the yardage and pipe length may vary slightly when the pond is staked in the field.*

All work must be completed in compliance with applicable state, local, federal and Osage Nation codes.
