The Osage Nation Ranch, LLC (ONR) is a wholly owned subsidiary of the Osage, **(LLC)**. The **LLC** is responsible for managing the Osage Nation Ranch, a 35,000+ acre cattle operation of the Osage Nation while protecting agricultural, environmental, and habitat interests. The ONR lies within the Osage Reservation **in an area that stretches Northwest of Hominy, East of Fairfax, West of Wynona and Southwest of Pawhuska, Oklahoma.**

ONR intends to award three (3) new Agreements through this solicitation. The proposals will be for three parcels of property. Submit bids for each Section and separately. Bids are to be made on a per head basis for all proposals. The tenant shall provide the care for their cow/calf pairs during the period of the agreement terms and no loss will be guaranteed. All cattle must be removed from the property by the last date of the agreement unless additional arrangements have been procured from Osage, LLC Board of Directors. Any cattle remaining on the property 14 days after the agreement has ended shall become the property of ONR.

The Osage, LLC reserves the right to reject any and all proposals. No attempt may be made at any time to induce any firm or person to refrain from submitting a proposal or to submit any intentionally noncompetitive proposal. All proposals must be made in good faith and without collusion.

Respondents proposal is an irrevocable offer for the term of the agreement. The awarded Respondent agrees to undertake the activities at the rates and fees as set forth in their proposal in response to this Solicitation.

The awarded respondent must adhere to the Laws of the Osage Nation. Any awardee found in violation of any laws, rules or regulations will be deemed a breach of agreement. The proposals must provide an irrevocable letter of credit (ILC).

A successful bid grants access to the appointed property for grazing purposes *ONLY*. Subtenants and subcontractors will not be allowed.

***NO HUNTING OR FISHING*** activity by the awarded respondent will be allowed.

Payment will be due in full at the time the agreement contract is signed.

ONR will accept bid proposals for a THREE (3) year COW/CALF ONLY grazing agreement. It is anticipated that the agreement will be effective starting **April 1, 2026** and terminate on **March 31, 2029**.

**The following sections of property are available for grazing – BID SEPARATELY:**

**Section #1** – COW/CALF ONLY – Coleman, Walker, Walker Bull Trap, South Lowe, North Tiger, North Lowe and East Johnson, Total acres 1705, total grass acres 1549, total allowable head 155

**Section #3** –COW/CALF ONLY – South goad, Hayworth, Bennett field, East Watkins, Little Watkins, Stuart, Harvey Bottom, Cox, Section 8, and Hog Total acres 6627, total grass acres 5521, total allowable head 546.

**Section #4 – STOCKERS ONLY** – Big Texaco, total acres 2164, total grass acres 1882, total allowable head 627, average maximum weight allowed upon entry 600 lbs., to be weighed on the ranch truck scales.
